### Customs Broker Appointment

(1) In consideration of NQCS accepting appointment as my customs agent, I authorise NQCS, their servants and agents to complete and sign declarations and statements on my behalf as required by the Act in relation to goods to be imported by me.

(7) If NQCS has any doubt about the accuracy of any information I give or my supplier gives to NQCS or in relation to the value or classification of goods to be imported by me, or if not enough information has been supplied to NQCS for the purpose of making a completed declaration or statement, I authorise NQCS to include in any statement or declaration disclosure of their uncertainty in relation to particular information or in relation to the omission of particular information.

(8) Where I do not authorise NQCS to make application for valuation and/or tariff advice and/or I do not authorise them to include in any statement or declaration disclosure of their uncertainty in relation to the omission of particular information and/or I have chosen not to complete the valuation and classification questionnaire and ...

(9) In further consideration of NQCS accepting appointment as my customs agent in an on-going capacity:

(10) I agree that NQCS, its servants and agents will not be responsible for or liable in damages to me for any loss, damages, fine, forfeiture or penalty I may suffer or incur arising from any false or misleading declaration or statement or from any omission from any declaration or statement made on my behalf in reliance upon the information which I have supplied to NQCS in the completed questionnaire and/or relevant commercial documents or which I or my supplier may give to NQCS in future; and

(11) I indemnify and agree to keep NQCS, its servants and agents indemnified against any claims or demands made against NQCS or them or in respect of any fines or penalties imposed upon NQCS or them arising from any declarations or statements NQCS or they make on my behalf based upon information which I or my supplier have given or may in future give to NQCS.
